# INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

S. B. No. 315-Senators Grendell, Jacobson, Fedor, Schuring.

To amend sections 2929.14 and 2929.19 of the Revised Code to establish a presumption that a court should impose on a repeat offender the longest prison term authorized for an offense and to require a court to state its reasons for not doing so.

**S. B. No. 316**-Senators Cates, Harris, Stivers, Wachtmann, Coughlin, Gardner, Carey, Padgett, Clancy, Mumper, Fingerhut, Jacobson.

To amend section 3767.30 of the Revised Code to prohibit protest activities within 500 feet of the site of a funeral service during and within one hour before and after the service and to prohibit protest activities within 500 feet of a funeral procession.

S. B. No. 317-Senator Cates.

To amend sections 2903.06 and 2903.08 of the Revised Code to provide that a person's operation of a motor vehicle, motorcycle, snowmobile, or watercraft while simultaneously using a mobile telephone generally constitutes as a matter of law recklessness for purposes of the offenses of aggravated vehicular homicide and vehicular assault.

S. B. No. 318-Senators Cates, Clancy.

To amend sections 2950.01, 2950.11, 2950.12, and 2950.13 of the Revised Code to provide notice to a long-term care facility and its residents when a registered sex offender will reside in the facility or when the facility is within the specified geographical notification area of the offender's residence.

**S. B. No. 319**-Senators Spada, Coughlin, Mumper, Clancy, Armbruster, Gardner, Schuring, Padgett, Niehaus, Hagan, Fingerhut, Prentiss, Miller, D., Fedor.

To enact sections 1522.01, 1522.02, and 1522.03 of the Revised Code to

ratify the Great Lakes-St. Lawrence River Basin Water Resources Compact and to establish related requirements.

**S. B. No. 320**-Senators Wachtmann, Gardner, Armbruster, Cates, Clancy, Spada, Fingerhut, Stivers, Schuler, Schuring, Prentiss, Grendell, Mumper, Zurz, Miller, R., Kearney.

To amend sections 5747.01, 5747.08, and 5747.98 and to enact section 5747.81 of the Revised Code to create an income tax deduction for expenses incurred by a taxpayer in making an organ donation and to create an income tax credit for deceased organ donors.
