INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

S. B. No. 175-Senators Goodman, Stivers, Clancy, Amstutz.

To enact section 5101.621 of the Revised Code to require that each county department of job and family services prepare a memorandum of understanding setting forth the normal operating procedures to be used when investigating abuse, neglect, and exploitation reports of older adults.

S. B. No. 176-Senators Fedor, Roberts, Hagan.

To amend section 3314.02 of the Revised Code to amend the definition of a "challenged school district" where new start-up community schools may be located.

OFFERING OF RESOLUTIONS

Senators Hagan, Dann offered the following resolution:

S. C. R. No. 19-Senators Hagan, Dann.

To urge the President and Congress of the United States to utilize all available trade remedy laws to prevent surges, dumping, and subsidized imports of steel pipes, tubes, and fittings into the United States market.
