INTRODUCTION AND FIRST CONSIDERATION OF BILLS

The following bills were introduced and considered the first time:

S. B. No. 177-Senator Grendell.

To amend section 319.302 of the Revised Code to extend the ten per cent real property tax rollback to certain land used for the commercial production of timber.

S. B. No. 178-Senators Grendell, Harris, Mumper, Armbruster, Clancy, Schuler, Schuring, Stivers, Dann.

To amend sections 122.173 and 5733.33 of the Revised Code to clarify that eligibility for the grants and credits for purchases of new manufacturing property includes only the taxpayer that is the owner of the property for federal income tax purposes.

S. B. No. 179-Senators Fingerhut, Armbruster, Spada.

To amend section 4301.99 and to enact section 4301.601 of the Revised Code to allow a wine manufacturer to deliver wine to a consumer in Ohio from a location within or outside Ohio under a delivery sale if certain requirements are fulfilled.
