Re: Ohio Consumers' Counsel Governing Board

Dear Senate President Harris:

In accordance with the Ohio Revised Code Section 4911.17, I have the honor to present to you for the advise and consent of the Ohio Senate the reappointment of John Moliterno, to the Ohio Consumers' Counsel Governing Board.

Pursuant to statute, the Governing Board is comprised of nine members consisting of three representatives for each of the following groups: organized labor, residential consumers and family farmers. Additionally, Ohio law requires that no more than five of the members of the Governing Board may be from the same political party. Mr. Moliterno is not a member of the Republican Party, he will be representing residential consumers, and has served as Governing Board member since his appointment in 2003. He has previously expressed interest in continuing to serve Ohio consumers in this capacity, and I welcome the opportunity to continue to work with him as a member of the Governing Board.
