**S. B. No. 183**-Senators Fingerhut, Dann, Fedor, Zurz, Roberts, Mallory, Gardner, Grendell, Schuring, Goodman, Padgett, Miller, Coughlin.

To amend section 5751.01 of the Revised Code and to repeal Section 557.09.09 of Am. Sub. H.B. 66 of the 126th General Assembly to exempt from the commercial activity tax amounts derived from the sale of property shipped into or from any foreign trade zone.

**S. B. No. 184**-Senator Gardner.

To amend sections 4511.21 and 4511.251 of the Revised Code to establish a 35-mile per hour speed limit for highways outside municipal corporations within island jurisdictions.

**S. B. No. 185**-Senators Padgett, Schuring.

To amend section 1345.01 of the Revised Code to expand the Consumer Sales Practices Act to cover transactions between two businesses.
