S. B. No. 197-Senators Roberts, Fedor, Fingerhut, Zurz, Hagan, Brady.

To amend sections 3314.08, 3314.084, 3314.13, 3317.02, 3317.029, 3317.0217, and 3317.03 of the Revised Code and to amend Section 206.09.39 of Am. Sub. H.B. 66 of the 126th General Assembly to eliminate the deduction of community school payments from the state funding accounts of a school district except for payments to community schools that are sponsored by the district.
