To amend Sections 206.66 and 206.67.08 of Am. Sub. H.B. 66 of the 126th General Assembly to increase the TANF Block Grant earmark for the Kinship Permanency Incentive Program by \$50 million in each fiscal year and to make an appropriation.

S. B. No. 241-Senators Miller, Dann, Fedor, Hagan.

To amend Section 206.66 of Am. Sub. H.B. 66 of the 126th General Assembly to earmark the TANF Block Grant \$10 million in each fiscal year for fatherhood programs and to make an appropriation.

S. B. No. 242-Senator Armbruster.

To amend sections 2151.011, 5103.13, and 5103.131 of the Revised Code regarding the certification of children's crisis care facilities.
