### **INTRODUCTION OF BILLS**

The following bills were introduced:

H. B. No. 438-Representative Hagan, R.

To amend sections 109.71, 109.73, and 109.79 and to enact sections 1711.351 and 1711.352 of the Revised Code relative to the appointment and commissioning of county agricultural society police officers and to the training of those officers.

H. B. No. 439-Representative Hagan, R.

To amend section 3314.03 and to enact section 3313.719 of the Revised Code to require each school district and each community school to provide suicide prevention services for students in grades five to twelve.

H. B. No. 440-Representatives Yuko, Lundy.

Cosponsors: Representatives Foley, Driehaus, Budish, Skindell, Koziura, Bolon.

To enact section 5321.20 of the Revised Code to provide that a rental agreement does not terminate upon the foreclosure of the landlord's mortgage.

**H. B. No. 441**-Representative Fessler. Cosponsors: Representatives Uecker, Webster, Stebelton, Adams, McGregor, J., Garrison, Williams, S., Chandler.

To amend section 4507.071 of the Revised Code to allow a court, under certain circumstances, to grant unaccompanied driving privileges one time to a probationary driver's license holder who, because of a moving violation, otherwise would be subject to a restriction that the person be accompanied by the holder's parent or guardian.

H. B. No. 442-Representative Letson.

Cosponsors: Representatives Foley, Yuko, Fende, Domenick, Hagan, R., Gerberry, Celeste, Stewart, D., Mallory, Williams, B.

To enact section 3109.054 of the Revised Code to require certain employers

to allow a parent to exercise court-ordered parenting time without terminating employment, reducing pay, or taking other similar action against the parent.

#### H. B. No. 443-Representative Peterson.

Cosponsors: Representatives Raussen, Evans, Brown, Fende.

To amend sections 7.12 and 5721.01 and to enact sections 7.16, 125.181, 125.182, 125.183, and 5721.012 of the Revised Code to establish the State-Sanctioned Public Notice web site, to permit any notice required to be published by statute or rule to be published on the web site, and to make changes to the qualifications for newspapers publishing public notices and the methods by which newspapers publish notice.
