INTRODUCTION OF BILLS

To amend sections 3501.38, 3513.041, 3513.261, and 3513.30 of the Revised Code to require a board of elections that distributes an incorrect petition to a person seeking to become a candidate to accept that petition as though it were the proper petition and to verify the signatures that appear on the petition; to require forms for nominating petitions for independent candidates and statements of candidacy for write-in candidates to be clearly identified at the top of the forms; and to require the secretary of state to prescribe, and boards of elections and the secretary of state to distribute, a standard withdrawal form for a candidate who wishes to withdraw as a candidate.
