The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

### H. B. No. 478-Representative Dodd.

Cosponsors: Representatives Dyer, Stewart, J., Bolon.

To amend sections 5747.08 and 5747.98 and to enact section 5747.72 of the Revised Code to allow a refundable tax credit against the personal income tax for concealed-carry license fees.

### H. B. No. 479-Representatives Evans, Foley.

Cosponsor: Representative Williams, B.

To amend section 742.03 of the Revised Code regarding election of the chairperson of the Ohio Police and Fire Pension Board of Trustees.

### H. B. No. 480-Representative Gardner.

Cosponsors: Representatives Brinkman, Wachtmann, Fessler, Combs, Sears.

To enact sections 306.322 and 306.55 of the Revised Code to create an additional procedure for subdivisions to join a regional transit authority that levies a property tax and that includes a county having a population of at least 400,000 and to allow a subdivision that is a member of such a regional transit authority to withdraw from the authority.
