The House met pursuant to adjournment.

The journal of yesterday was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 81-Representative Brown.

Cosponsors: Representatives Evans, Combs, Strahorn, Yuko, Otterman, Redfern, Chandler, Fende, Williams, B., Ujvagi.

To amend section 3313.671 and to enact sections 3701.36, 3701.361, and 3701.362 of the Revised Code to require that girls entering the sixth grade be vaccinated against the human papillomavirus (HPV) and to create the HPV Immunization Advisory Committee.

H. B. No. 82-Representative Chandler.

Cosponsors: Representatives Okey, Stewart, J., Brown, Koziura, Yuko, Skindell, Harwood.

To enact section 4511.773 of the Revised Code to require all school buses purchased, leased, or rented after January 1, 2010, to transport students to and from school to be equipped with a seat belt assembly for all passengers.

H. B. No. 83-Representative DeBose.

To amend sections 2929.14, 2929.24, 2950.99, and 4511.203 and to enact sections 2941.1421, 2950.15, and 4503.237 of the Revised Code to create a SORN Law license plate; to provide mandatory prison terms and jail terms for persons convicted of a sexually oriented or child-victim oriented offense who are subject to a SORN Law license plate order and use a motor vehicle without such license plates in committing the offense, to arrive at the location where it was committed, or to flee immediately after committing it; and to expand the offense of "wrongful entrustment of a motor vehicle" to apply to a person who in specified circumstances permits a person subject to a SORN Law license plate order to drive the offender's motor vehicle without such license plates.

H. B. No. 84-Representative Hottinger.

Cosponsors: Representatives Peterson, McGregor, R., Koziura, Setzer, Adams, Collier.

To amend sections 303.211 and 519.211 of the Revised Code to expand township and county zoning authority to telecommunications towers located on land used for agricultural purposes and to modify notice requirements for a proposed tower.

H. B. No. 85-Representative Webster.

To amend sections 3333.01, 3333.03, 3333.04, 3333.05, 3333.07, 3333.10, and 3333.99 and to enact sections 3333.45, 3333.46, and 3345.02 of the Revised Code to expand the authority of the Ohio Board of Regents to regulate the programs and tuition of state institutions of higher education, to require the Governor's approval of the Board of Regent's selection for Chancellor, to restructure the terms of members of the Board of Regents, and to establish the Ohio Higher Education Purchasing Commission.

H. B. No. 86-Representative Wachtmann.

Cosponsors: Representatives Brinkman, Latta, Seitz, Hottinger, Schneider, Setzer, Dodd, Wolpert, Goodwin, Fessler, Bubp, Collier, Combs, Wagoner, Wagner, McGregor, J., Huffman.

To amend section 124.85 of the Revised Code to prohibit the state offering, sponsoring, or endorsing a health insurance policy that covers nontherapeutic abortion.

H. B. No. 87-Representative Wachtmann.

To enact section 5533.811 of the Revised Code to designate a bridge on State Route 108 over the Maumee River as the "Henry County Veterans Bridge."

Said bills were considered the first time.
