### INTRODUCTION OF BILLS

The following bills were introduced:

### H. B. No. 507-Representative Sayre.

To amend sections 3319.51, 5747.08 and 5747.98 and to enact section 5747.71 of the Revised Code to allow teachers to pay license renewal fees in annual installments, and to allow a refundable credit against the income tax for educator licensing fees and educator-paid criminal records check fees.

To amend section 1333.99 and to enact section 1333.58 of the Revised Code to require that ticket brokers register with the Department of Commerce and to prohibit a ticket broker from purchasing tickets from the original ticket seller.

To amend sections 1545.09 and 1545.99 of the Revised Code to provide increased penalties for violations of a bylaw or rule adopted by a board of park commissioners of a park district in a county and to permit a board of park commissioners to adopt penalties for any such violation provided the penalties do not exceed in severity the penalty designated by state law for a similar violation under state law.
