INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 123-Representative Collier.

To amend sections 6101.48 and 6101.53 of the Revised Code to prohibit the levying of an assessment by the board of directors of a conservancy district on land that is owned by a church within the district unless the governing authority of the church requests that the church's land be subject to the assessment.

H. B. No. 124-Representative Evans.

To amend section 4501.21 and to enact section 4503.553 of the Revised Code to establish "Ohio's Horse" license plates and to provide that money from the contributions for the license plates be paid to the Ohio Coalition for Animals, Incorporated.

H. B. No. 125-Representative Huffman.

To amend sections 1751.13 and 1753.09, to enact sections 3963.01 to 3963.09, and to repeal sections 1753.03, 1753.04, 1753.05, and 1753.08 of the Revised Code to establish certain uniform contract provisions between health care providers and third-party payers, to establish standardized credentialing, and to require third-party payers to provide to health care providers specified information concerning enrollees.
