H. B. No. 140-Representative Widener.

To amend sections 4513.01 and 4513.62 and to enact sections 4513.621, 4513.622, and 4513.66 of the Revised Code to provide that the owner of a motor vehicle that is removed from a public road may be prevented from registering any vehicle until the towing and storage fees on the vehicle removed are paid.

H. B. No. 141-Representative Letson.

Cosponsors: Representatives Hagan, R., Fende, Harwood, Williams, B., Mallory, Carano, Skindell, Miller, Budish, Yuko, Brown, Strahorn, Lundy, Foley.

To amend sections 2903.13 and 2903.21 of the Revised Code to make an assault or aggravated menacing committed in a courthouse a felony of the fifth degree.

H. B. No. 142-Representative Batchelder.

Cosponsors: Representatives Bacon, Williams, B., Combs, Chandler, Bubp, Fessler, Latta, Harwood, Fende, Adams, Wachtmann, White, Collier.

To amend sections 2917.31, 4501.11, and 5503.02 of the Revised Code to authorize the state highway patrol to provide emergency assistance to a school district confronted with a bomb threat or a similar threat of imminent and catastrophic harm, and to increase the penalty for inducing panic to a felony of the second degree when a school is involved.

Said bills were considered the first time.
