INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 148-Representative Wachtmann.

To amend section 4759.02 and to enact sections 4783.01, 4783.02, 4783.03, 4783.04, 4783.05, 4783.06, 4783.07, 4783.08, 4783.09, 4783.10, 4783.11, 4783.12, 4783.13, 4783.14, and 4783.15 of the Revised Code regarding the provision of complementary or alternative health care services.

H. B. No. 149-Representatives Daniels, Strahorn.

To amend sections 4725.01, 4725.09, 4725.16, 4725.23, 4725.26, 4725.28, and 4731.44 and to enact sections 4725.011, 4725.012, and 4725.091 of the Revised Code to modify the laws governing the State Board of Optometry and the practice of optometry, including the laws authorizing optometrists to administer and prescribe drugs.

H. B. No. 150-Representative McGregor, J.

Cosponsors: Representatives Adams, Peterson, Luckie, Skindell.

To enact sections 4173.01, 4173.02, and 4173.03 of the Revised Code as a "good Samaritan law" to encourage retail establishments to allow customers with eligible medical conditions to use the retail establishment's restrooms that are not usually available to the public and to limit the liability of an establishment that allows such access.

H. B. No. 151-Representatives Mandel, Jones.

To amend section 135.143 and to enact sections 117.103 and 137.01 to 137.09 of the Revised Code to prohibit any public investor or any asset manager investing on behalf of any public investor from investing in a foreign company with active business ties or operations in or with the Islamic Republic of Iran and to require that any existing investments in such companies be divested in order to protect the public investments of the State of Ohio from global security risk-related losses.

Said bills were considered the first time.
