Representative Hagan, J. was selected to preside under the Rule.

The journal of yesterday was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 161**-Representative Raussen.

Cosponsors: Representatives McGregor, J., Setzer, White, Collier, Fessler, Williams, S., Bulp, DeGeeter, Domenick, Fende, Budish.

To enact section 5321.171 of the Revised Code to permit a tenant to terminate a residential rental agreement without penalty if the tenant or the tenant's spouse is 62 years of age or older and, for medical reasons, enters a nursing home or other specified care facility.

**H. B. No. 162**-Representative Luckie.

Cosponsors: Representatives Ujvagi, Healy, Hughes, Stebelton, Domenick.

To amend sections 5747.08 and 5747.98 and to enact section 5747.71 of the Revised Code to allow a refundable credit against the personal income tax for taxpayers who teach in and reside in a big eight school district and to allow an additional credit for such teachers who teach math, science, or technology.

**H. B. No. 163**-Representative Distel.

Cosponsors: Representatives McGregor, J., Seitz, Latta, Setzer, Dodd, Ujvagi, Garrison, Fende, DeGeeter, Stebelton, Yuko, Hughes, Harwood.

To enact section 5533.281 of the Revised Code to designate State Route 11 within Ashtabula County only the "Marine Private Henry Kalinowski Memorial Highway."

**H. B. No. 164**-Representative McGregor, R.

Cosponsors: Representatives McGregor, J., Huffman, Evans, Skindell, Seitz, Dodd, Widener, Flowers, Stewart, J., Gibbs, Stebelton, Stewart, D., Bacon, Daniels, Miller, Foley, Wachtmann, Chandler, Peterson.

To amend section 2305.2341 and to enact section 3701.047 of the Revised Code to require the Ohio Department of Health to promote the establishment

of federal health centers, to include federally qualified health center look-alikes in the medical malpractice premium assistance program, to create a pilot program to place federally qualified health centers in two hospital emergency departments, and to make an appropriation.

**H. B. No. 165**-Representative Gibbs.

Cosponsors: Representatives McGregor, J., Hagan, J., Adams, Carmichael.

To amend sections 5739.03, 5739.031, 5739.033, 5739.035, 5739.123, and 5741.02 and to enact section 5741.09 of the Revised Code to require vendors using origin-based situsing rules to determine the appropriate sales tax jurisdiction in which a sale is taxable to continue to do so, to authorize vendors using destination-based sourcing to convert to origin-based situsing at their convenience, to repeal Ohio's multiple points of use provisions for services and computer-related sales, and to authorize the Tax Commissioner to develop a plan for in-state and out-of-state vendors to elect to collect and remit Ohio use taxes at a uniform rate.

Said bills were considered the first time.
