The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bills were introduced:

To amend section 5747.98 and to enact sections 122.85 and 5747.66 of the Revised Code to authorize income tax credits for investments in motion pictures produced in Ohio.

To amend section 2921.22 and to enact sections 3313.668 and 3314.19 of the Revised Code to provide for the reporting of assaults in public schools to school administrators and law enforcement authorities.

To create the Ohio Foster Care Oversight Committee to produce recommendations relating to the reform of Ohio's foster care system.

To enact section 105.411 of the Revised Code to direct the Capitol Square Review and Advisory Board to promote erection on the capitol grounds of a monument honoring the Ohio Tuskegee Airmen.

To amend sections 5139.01, 5139.04, 5139.05, 5139.06, 5139.07, 5139.09, 5139.11, and 5139.13 and to enact section 5139.12 of the Revised Code to require the Department of Youth Services to establish and maintain multifactored assessment programs for, and to prepare individualized rehabilitation plans for, specified felony delinquents.

**H. B. No. 203**-Representative Boyd.

To amend sections 5145.03, 5145.04, 5145.16, and 5145.161 and to enact section 5120.113 of the Revised Code to require the Department of Rehabilitation and Correction to establish and maintain multifactored assessment programs for, and to prepare individualized rehabilitation plans for, specified inmates.

**H. B. No. 204**-Representative Boyd.

To amend sections 109.57, 109.572, 3313.20, and 3319.39 and to enact sections 109.781, 109.782, 109.783, 109.784, 3313.175, 3313.176, 3313.177, 3313.178, 3313.179, and 3313.1710 of the Revised Code to permit the board of a school district or educational service center to employ school security personnel officers and to authorize training programs that qualify persons as school security personnel officers.

**H. B. No. 205**-Representative Goodwin.

To enact section 2945.60 of the Revised Code to require that upon final

disposition of a criminal proceeding any obscene material involving a minor remain in the custody and control of the prosecuting attorney or court.
