### INTRODUCTION OF BILLS

The following bill was introduced:

### H. B. No. 550-Representatives Flowers, Driehaus.

To amend sections 4931.61, 4931.62, 4931.63, 4931.64, 4931.65, 4931.66, and 4931.70 of the Revised Code to extend until 2013 the wireless 9-1-1 charge, to raise the minimum, annual fund disbursement amount for each county from \$25,000 to \$90,000, and to broaden local uses of that revenue.

Said bill was considered the first time.
