The House met pursuant to adjournment.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 241-Representative Heard.

Cosponsors: Representatives Miller, Brady, Boyd, Budish, Fende, Dodd, Mallory, Harwood, Domenick, Collier, Bolon.

To amend sections 2950.031 and 2950.99 of the Revised Code to provide that any person required to register under Ohio's Sex Offender Registration and Notification Law who establishes or occupies residential premises within one thousand feet of any school premises, recreation center, playground, or other place where it is reasonable to expect children to frequent or linger is guilty of a misdemeanor of the first degree and to require a court to order a violator to vacate the premises as part of any injunctive relief granted for the violation.

H. B. No. 242-Representative Brinkman.

Cosponsors: Representatives Adams, Wachtmann.

To amend sections 9.81, 4113.02, 4117.03, 4117.05, 4117.09, and 4117.11;

to amend, for the purpose of adopting a new section number as indicated in parentheses, section 4113.02 (4119.04); and to enact sections 4117.031, 4117.081, 4119.01, 4119.02, 4119.03, 4119.05, 4119.06, 4119.07, and 4119.99 of the Revised Code to remove any requirement under the Public Employees Collective Bargaining Law that public employees join or pay dues to any employee organization, to expand the scope of unfair labor practices under that law, to make other changes in the Public Employees Collective Bargaining Law, to prohibit any requirement that employees of private employers join or pay dues to any employee organization and to require public and private employers to post notices to that effect, to prohibit certain actions by private employers relative to employee organization membership, and to establish civil and criminal penalties against private employers who violate those prohibitions.

H. B. No. 243-Representative Brinkman.

To amend sections 121.08, 164.07, 166.02, 176.011, 307.022, 307.671, 307.673, 307.674, 307.696, 351.06, 1311.25, 1509.071, 1521.26, 1551.33, 1710.02, 1728.07, 3383.07, 4116.01, 4582.12, 5540.03, and 6117.012 and to repeal sections 122.0818, 122.452, 165.031, 176.05, 1551.13, 3706.042, 4115.03, 4115.031, 4115.032, 4115.033, 4115.034, 4115.04, 4115.05, 4115.06, 4115.07, 4115.071, 4115.08, 4115.09, 4115.10, 4115.101, 4115.11, 4115.12, 4115.13, 4115.131, 4115.132, 4115.133, 4115.14, 4115.15, 4115.16, 4115.21, 4115.99, 4582.37, 4981.23, and 6121.061 of the Revised Code to repeal the Prevailing Wage Law.

H. B. No. 244-Representative Brinkman.

To amend sections 515.04, 515.05, 515.08, 515.11, 515.12, and 515.15 and to enact section 515.16 of the Revised Code to authorize townships to relocate underground overhead cables, wires, and appurtenant equipment upon petition; to pay for a relocation by assessing abutting and otherwise specially benefited properties; to collect interest on unpaid assessments for an underground relocation project or an artificial lighting district project; and to exempt townships from liability for outages or other damage caused by a relocation project, and to exempt the owners of the cables, wires, and appurtenant equipment from liability, unless the outage or other damage was caused by the owner's negligence.

H. B. No. 245-Representative Strahorn.

To amend sections 3317.012 and 3317.02 of the Revised Code to modify the method of adjusting the per-pupil formula amount for school districts from year to year.

H. B. No. 246-Representative Stewart, J.

To amend sections 1711.11 and 1711.53 and to enact section 3717.14 of the Revised Code to require concession owners and operators, amusement ride owners and operators, and certain food establishments to provide the names and addresses of their employees when requested by the chief of police or county sheriff.

H. B. No. 247-Representative Brown.

Cosponsors: Representatives Koziura, Chandler, Ujvagi, Williams, S., Williams, B., Yuko, Brady, Miller, DeGeeter, Otterman, Domenick, Luckie, Wagoner, Strahorn, Skindell, DeBose, McGregor, J., Driehaus.

To amend sections 2151.23, 2903.213, 2903.214, 2919.25, 3113.31, and 3113.33 of the Revised Code to allow a court to issue a civil protection order to a child who has had or has a dating relationship with the respondent if certain offenses are alleged and to include foster parents under the scope of the domestic violence laws.

H. B. No. 248-Representative Blessing.

To enact section 1349.55 of the Revised Code to set forth requirements governing non-recourse civil litigation advance contracts.

H. B. No. 249-Representative McGregor, R.

Cosponsors: Representatives Wagoner, McGregor, J., Flowers, Seitz, Skindell, Stebelton, Lundy.

To enact sections 5111.028 and 5111.029 of the Revised Code to modify the Medicaid program's reimbursement rate for medical transportation services.

H. B. No. 250-Representative Jones.

To amend sections 4929.01 and 4929.02 and to enact section 4929.051 of the Revised Code relative to revenue decoupling for natural gas utilities and energy conservation.

H. B. No. 251-Representatives Peterson, Yates.

Cosponsors: Representatives Stewart, D., Hagan, R., Dyer, Foley, Skindell, Ujvagi, Stebelton, Miller, Koziura, Healy, Budish, Luckie, Yuko, Chandler, Strahorn, Letson, DeBose, Beatty, Celeste.

To amend sections 2907.29, 3313.6011, and 4729.16; to enact sections 1751.661, 3701.047, 3701.135, 3727.11, 3727.12, 3923.602, 3923.611, 4729.43, and 4729.45; to repeal section 3701.046 of the Revised Code; to amend Section 206.42.03 of Am. Sub. H.B. 66 of the 126th General Assembly; to amend Section 206.42.09 of Am. Sub. H.B. 66 of the 126th General Assembly, as subsequently amended; and to repeal Section 206.42.06 of Am. Sub. H.B. 66 of the 126th General Assembly regarding assistance for pregnancy prevention.
