INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 252-Representative Hughes.

Cosponsors: Representatives McGregor, J., Healy, Evans, Goyal, Zehringer, Setzer, Chandler, Yuko, Skindell, Bubp, Collier, Letson, Wagoner, Fende.

To enact section 5501.70 of the Revised Code to require the Director of Transportation to designate portions of state highways, county or township roads, or streets or highways located within municipal corporations as memorial highways in honor of each State Highway Patrol trooper, county sheriff, deputy sheriff, township constable, or police officer of a township police department or district or law enforcement agency of a municipal corporation who is or has been killed in the line of duty.

H. B. No. 253-Representative Oelslager.

Cosponsors: Representatives McGregor, J., Collier, Letson, Chandler, Okey, Wachtmann, Healy.

To amend sections 3719.06, 4723.481, 4723.482, 4723.492, and 4723.50 of the Revised Code to modify the authority of certain advanced practice nurses to prescribe schedule II controlled substances.

To amend sections 5301.01 and 5301.255 of the Revised Code to provide that memoranda of trust be executed and acknowledged only by the trustee of the trust instead of both the settlor and trustee.
