INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 254-Representatives Peterson, Strahorn. Cosponsors: Representatives Boyd, Celeste, Chandler, Combs, Domenick, Flowers, Foley, Garrison, Hagan, R., Harwood, Healy, Heard, Hughes, Koziura, Luckie, Lundy, Mallory, McGregor, J., Raussen, Schneider, Skindell, Stewart, D., Webster, Williams, B., Wolpert, Yuko.

To amend sections 3302.04, 3313.813, 3313.814, 3314.03, 3314.18, 3319.29, 3319.291, and 3319.31 and to enact sections 3301.20, 3301.80, 3313.816, 3313.817, 3313.82, and 3319.223 of the Revised Code to establish the Ohio Child Wellness Advisory Council, to establish nutritional standards for certain foods and beverages sold in public and chartered nonpublic schools, to require public and chartered nonpublic schools to implement local wellness policies, and to make other changes regarding student nutrition and physical activity.

H. B. No. 255-Representative Latta.

To amend sections 2111.10, 2115.06, 2317.02, and 3313.85 of the Revised Code to allow appointment of a nonprofit corporation or public agency as guardian of a person, allow an executor or administrator to accept the county auditor's valuation of real estate, provide that the testimonial privilege between a physician or dentist and a patient does not apply in certain guardianship, adult protective services, commitment, or institutionalization proceedings, eliminate the requirement that a probate court act as a board of

education, or governing board of an educational service center that fails to perform its duties, and require a probate court to promptly fill a school board vacancy not filled within 30 days.

To amend sections 121.22 and 149.43 and to enact sections 2743.31, 2743.32, 2743.33, and 2743.34 of the Revised Code to establish the office of Public Access Counselor in the Court of Claims to receive complaints and issue advisory opinions concerning the Public Records Law and Open Meetings Law.

H. B. No. 257-Representative Schneider.

To amend sections 121.08 and 4745.01 and to enact sections 4768.01 to 4768.19 and 4768.99 of the Revised Code to require the certification of home inspectors and to regulate the certification and performance of home inspectors.
