# INTRODUCTION OF BILLS

# H. B. No. 314-Representative Jones.

To amend section 4731.22 and enact section 2317.561 of the Revised Code to require that a woman who is to have an abortion be given the opportunity to view any available obstetric ultrasound image.

# H. B. No. 315-Representative Oelslager.

Cosponsors: Representatives Lundy, Yuko, Barrett, Evans, Healy, Okey, Seitz, Szollosi, Hughes, Brown, Williams, B., Chandler, Boyd, Dyer.

To amend sections 3307.14, 3307.141, 3307.19, 3307.26, 3307.28, 3307.292, 3307.35, 3307.351, 3307.352, 3307.39, and 3307.61 and to enact sections 3307.143, 3307.262, and 3307.281 of the Revised Code to create the Health Care Fund in the State Teachers Retirement System (STRS) and make other changes in STRS law.

# H. B. No. 316-Representative Seitz.

Cosponsors: Representatives Blessing, Yuko, Fessler, Huffman, Bubp, Schneider, Adams.

To amend sections 3794.01 and 3794.03 of the Revised Code to allow smoking in cigar bars and in outdoor seating areas of restaurants that are at least 20 feet away from an entrance, exit, or window of the restaurant.
