INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 322-Representatives Hughes, Skindell.

Cosponsors: Representatives Foley, Hagan, R., McGregor, J., Setzer, White, Stebelton, Flowers, Uecker, Fende, Yuko, Luckie, Healy, Koziura, Boyd, Otterman, Williams, B., Stewart, D.

To enact section 153.73 of the Revised Code to require the Director of Administrative Services to adopt rules governing construction and demolition debris recycling and water and energy usage with respect to certain public works projects.

H. B. No. 323-Representative Gibbs.

Cosponsors: Representatives Peterson, McGregor, J., Evans, Huffman, Wagner, Miller, Fessler, Seitz, Bulp, Okey, McGregor, R., Fende.

To amend sections 971.01, 971.04, 971.05, 971.06, 971.07, 971.08, 971.09, 971.10, 971.33, 971.34, and 971.99; to amend for the purpose of adopting new section numbers as indicated in parentheses sections 971.04 (971.09), 971.05 (971.10), 971.06 (971.11), 971.07 (971.12), 971.08 (971.13), 971.09 (971.14), and 971.10 (971.15); to enact new sections 971.02, 971.03, 971.04, 971.05, 971.06, 971.07, 971.08, 971.16, 971.17, and 971.18; and to repeal sections 971.02, 971.03, 971.11, 971.12, 971.13, 971.14, 971.15, 971.16, 971.17, 971.18, 971.21, 971.22, 971.23, 971.24, 971.25, 971.26, 971.27, 971.28, 971.29, 971.30, 971.31, and 971.32 of the Revised Code to revise the Fences Law.

H. B. No. 324-Representative Batchelder.

To amend section 5739.01 of the Revised Code to exempt physical fitness facility and recreation and sports club membership fees from the sales tax if the facility or club is owned or controlled by a nonprofit, income tax-exempt

organization operated for religious or charitable purposes.

H. B. No. 325-Representative Gerberry.

To amend section 4503.53 of the Revised Code to establish a veteran's license plate available to active duty and honorably discharged persons who, while serving in the armed forces of the United States, served in Afghanistan during Operation Enduring Freedom or in Iraq during Operation Iraqi Freedom.

H. B. No. 326-Representative Gerberry.

Cosponsors: Representatives Bolon, Book, Dodd, Fende, Harwood, Letson, Okey, Seitz.

To enact section 3345.063 of the Revised Code to require state institutions of higher education to include coursework in government as a condition of awarding an undergraduate degree, diploma, or certificate.

H. B. No. 327-Representative McGregor, J.

Cosponsors: Representatives Skindell, Webster.

To amend sections 133.01, 140.03, 3701.15, 3701.342, 3707.01, 3709.01, 3709.11, 3709.14, 3709.15, 3709.28, 3709.31, 3709.32, 3709.34, 5705.01, 5705.31, 5709.40, 5709.73, and 5709.78, to enact new sections 3709.08 and 3709.29 and sections 319.282, 3701.36, 3709.011, 3709.092, and 3709.311, and to repeal sections 3709.08, 3709.081, and 3709.29 of the Revised Code with regard to boards of health of city and general health districts.
