INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 328-Representative Patton.

To amend section 3750.20 and to enact section 3750.23 of the Revised Code to require rail owners and operators to secure rail facilities and equipment from the threat of terrorism through the development of a vulnerability assessment, an infrastructure protection program, and proper communication with public authorities and to provide civil penalties for noncompliance by a rail owner or operator.

H. B. No. 329-Representative Patton.

To amend section 5739.02 of the Revised Code to exempt sales of clothing worth less than \$100 from sales and use taxation.

H. B. No. 330-Representative Healy.

Cosponsors: Representatives Brown, Letson, McGregor, J., Okey, Skindell, Yuko, Webster.

To amend sections 2313.06, 2313.08, and 2313.42 of the Revised Code to require that the annual jury list be made up from the list of qualified driver licensees and holders of identification cards issued by the Registrar of Motor Vehicles and, at the discretion of the commissioners, from volunteers from the list of electors provided by the board of elections.
