The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Hite was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 331-Representative Wagoner.

To amend sections 3701.83, 3702.11, 3702.55, and 3709.09; to enact sections 3711.14, 3711.16, 3711.20, 3711.21, and 3711.22; to enact new sections 3711.01, 3711.02, 3711.04, 3711.06, 3711.08, 3711.10, and 3711.12; and to repeal sections 3711.01, 3711.02, 3711.021, 3711.03, 3711.04, 3711.05, 3711.06, 3711.07, 3711.08, 3711.09, 3711.10, 3711.11, 3711.12, 3711.13, and 3711.99 of the Revised Code regarding the licensure of maternity homes and obstetric and newborn care facilities.

H. B. No. 332-Representative Wagoner.

To amend sections 111.16, 1329.01, 1329.04, and 2329.66 and to enact sections 1775.66, 1776.01 to 1776.08, 1776.10 to 1776.12, 1776.21 to 1776.24, 1776.31 to 1776.38, 1776.41 to 1776.58, 1776.61 to 1776.79, 1776.81 to 1776.89, 1776.91, 1776.92, 1776.95, 1776.96, 1777.07, 1779.12, 1782.64, and 2307.30 of the Revised Code to adopt the Revised Uniform Partnership Act to be known as the "Ohio Uniform Partnership Act (1997)," to establish that on and after January 1, 2009, the act governs new partnerships and partnerships that elect to be governed by the act, to establish that effective January 1, 2010, the act governs all partnerships in Ohio, and to establish that effective January 1, 2010, the existing Ohio Partnership Law no longer governs partnerships.

To amend sections 135.63, 1315.35, 1315.36, 1315.39, 1315.40, 1315.41, 1321.13, 1321.131, 1349.72, and 1733.25 and to enact sections 135.68, 135.69, 135.70, and 1315.45 of the Revised Code to prohibit a check-cashing business from making a loan to a borrower who has an outstanding loan with any check-cashing licensee, to create a statewide database of loans by check-cashing licensees, to modify the terms for making a loan under the check-cashing loan act, to create a small loan linked deposit program, to expand the responsibilities of the consumer finance education board to promote small loan counseling and education for borrowers, and to eliminate a certain credit union lending option.

To enact section 5.2236 of the Revised Code to designate September as "Ovarian Cancer Awareness Month."

H. B. No. 335-Representative DeBose.

To enact sections 1751.69, 3923.90, 3923.91, 3923.92, and 5111.026 of the Revised Code to require certain health care insurers and plans, including the state's Medicaid program, to provide benefits for prostate, colorectal, cervical, and ovarian cancer screening examinations.

H. B. No. 336-Representative Dyer.

To amend sections 3509.04, 3509.05, 3511.05, and 3511.11 of the Revised Code to permit absent voter's ballots and armed service absent voter's ballots contained in envelopes that are postmarked prior to election day to be counted if they are received within ten days after election day, to permit ballots received during that time that are contained in envelopes that are not postmarked or that have an illegible postmark to be counted, and to permit the Secretary of State, by rule, to specify standards for absent voter's ballot return envelopes to ensure that those envelopes are clearly identifiable as ballot envelopes for the purpose of postmarking.

H. B. No. 337-Representatives McGregor, R., Lundy.

To amend sections 1181.06, 1315.36, 1315.39, 1315.40, and 1315.41 and to enact section 121.085 of the Revised Code to modify terms and permissible charges under the Check-Cashing Lender Law, to establish the Financial Literacy Education Fund, to authorize the Director of Commerce to administer the fund and establish adult financial literacy education programs, and to create the Small Emergency Loan Task Force.

H. B. No. 338-Representative Reinhard.

To enact sections 122.84, 122.841, 122.842, 122.843, 122.844, and 5727.451 of the Revised Code to create a program to provide funding for utility infrastructure development projects to attract new business opportunities for the state.

H. B. No. 339-Representative Ujvagi.

To amend section 4513.03 of the Revised Code to require the headlights of a vehicle to be lighted when its windshield wipers are in use.

Said bills were considered the first time.

BILLS FOR THIRD CONSIDERATION**Sub. H. B. No. 214**-Representatives Wagner, Combs.

Cosponsors: Representatives Seitz, McGregor, J., Stebelton, Brown.

To amend sections 2151.152, 2151.23, 2151.39, 3313.64, 5103.031, 5103.032, 5103.035, 5103.0312, 5103.0313, 5103.16, 5103.391, 5126.04, 5153.122, and 5153.123 and to enact sections 5103.23, 5103.231, 5103.232, 5103.233, 5103.234, 5103.235, 5103.236, and 5103.237 of the Revised Code relative to training for foster caregivers, department of job and family services authority to begin the child placement level of care pilot program and petition Congress for expanded usage of Title IV-E funding, the Interstate Compact on the Placement of Children, and the coordination of the provision of services for foster children with mental retardation or developmental disabilities , was taken up for consideration the third time.

The question being, "Shall the bill pass?"

Representative Daniels moved that **Sub. H. B. No. 214**-Representatives Wagner, Combs, et al., be informally passed and retain its place on the calendar.

The motion was agreed to.
