#### **INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 349**-Representatives Hughes, Goyal. Cosponsors: Representatives Brown, Letson, Huffman, Fende, Driehaus, Distel, Budish, Williams, S., Sayre, Oelslager.

To amend sections 3731.01 and 3731.04 and to enact section 3731.17 of the Revised Code to allow transient hotels to permit guests to stay longer than thirty days and to allow extended stay hotels to permit guests to stay longer than one year.

H. B. No. 350-Representative Wolpert.

Cosponsors: Representatives Batchelder, Huffman, Evans, Peterson, Fende, Flowers, Williams, S., Webster, Bubp, Combs, Brown.

To amend section 3501.22 of the Revised Code to permit a student at an Ohio institution of higher education to serve as a precinct election official in the county where they attend school, and to permit up to two high school seniors to serve as precinct officers at a polling place with six or more precinct officers.
