INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 392-Representative McGregor, J.

To enact section 4501.81 of the Revised Code to establish a next of kin database within the Bureau of Motor Vehicles.

H. B. No. 393-Representative Yates.

To amend sections 3717.01 and 3717.05 of the Revised Code to prohibit the use of trans fats by food service operations and certain retail food establishments.

H. B. No. 394-Representatives Bubp, Widener.

To enact sections 5533.101 and 5533.791 of the Revised Code to designate a portion of United States Route 50 located in Clermont County the "LCPL Nicholas B. Erdy Memorial Highway" and to designate State Route 334 in Clark County as the "Lance Cpl. Kevin S. Smith Memorial Highway."

H. B. No. 395-Representative Hughes.

Cosponsors: Representatives Flowers, Wagoner, Evans, Yuko, Williams, S.

To amend sections 2903.214, 3105.171, and 3113.31 and to enact section 3113.311 of the Revised Code to provide a procedure for the return of personal property held by a law enforcement agency upon the expiration or termination of a protection order and to generally exclude a spouse's social security benefits from a divorce court's jurisdiction.

Said bills were considered the first time.
