The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Daniels was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 648-Representative Jones.

Cosponsors: Representatives Batchelder, Hottinger, Stebelton, Bubp, Nero, Grady, Setzer, Adams, Schindel, Wachtmann, Gardner, Widener, Brinkman, Zehringer, Uecker, Mecklenborg, Wagner, McGregor, R., McGregor, J., Combs, Sears, Goodwin.

To amend section 1347.99 and to enact sections 1347.15 and 5703.211 of the Revised Code to require state agencies to adopt rules governing access to the confidential personal information that they keep, to create a civil action for harm resulting from an intentional violation of these rules, to impose a criminal penalty for such an intentional violation, and to require the Department of Taxation to adopt rules to require the tracking of searches of any of the Department's databases.

H. B. No. 649-Representative Hottinger.

To amend section 5902.02 and to enact sections 5902.16 and 5902.161 of the Revised Code to provide compensation to veterans of the Persian Gulf, Afghanistan, and Iraq conflicts.

H. B. No. 650-Representative Blessing.

To amend sections 303.211 and 519.211 of the Revised Code to enact as a separate act the provisions of law that specify that a public utility does not include a person that owns or operates a solid waste facility, solid waste transfer facility, or construction and demolition debris facility for the purposes of the law that states that boards of county commissioners, boards of township trustees, and boards of zoning appeals do not have the power to adopt zoning requirements applicable to public utilities.

H. B. No. 651-Representative Gardner.

To amend sections 315.02 and 315.14 of the Revised Code to remove the requirement that a county engineer be a registered surveyor in addition to being a registered professional engineer in order to hold or be eligible as a candidate for the office.

H. B. No. 652-Representative Batchelder.

To amend sections 101.532, 101.82, 127.14, 4121.03, 4121.121, 4121.75, 4121.76, 4121.77, 4121.79, 4123.341, 4123.342, and 4123.35 of the Revised Code to make changes to the law governing the Workers' Compensation Council and to make an appropriation.

Said bills were considered the first time.
