WHEREAS, Howard Metzenbaum left an indelible impression on the people whose lives he touched, and he will be remembered as a spirited individual who contributed immeasurably to the world around him. A lawyer and an astute businessman, he operated twenty-three storefront tax preparation offices before serving in the Ohio House of Representatives from 1943 through 1946 and in the Ohio Senate from 1947 through 1950. The co-founder of the Airport Parking Company of America and past president of the Consumer

Federation of America, he was appointed to fill an unexpired term in the United States Senate in 1973 and was reelected to three terms in 1976, 1982, and 1988, becoming known for leading filibusters and playing leading roles in passing bills requiring nutrition labels on processed foods and banning semi-automatic weapons; and

WHEREAS, Also active with the American Cancer Society, Cystic Fibrosis Foundation, and Northern Ohio Children's Performing Music Foundation, Inc., Howard Metzenbaum diplayed a regard for improving the quality of life in our society that was clearly evident in his personal sacrifices of time and effort to his family, friends, and community. Giving generously of his energy and abilities in all of his endeavors, he demonstrated exceptional concern and insight, and his absence will be keenly felt; and
