**INTRODUCTION AND FIRST CONSIDERATION OF BILLS**

The following bill was introduced and considered the first time:

**S. B. No. 173**-Senator Cates.

To amend sections 955.02, 955.10, 955.12, 955.20, 955.26, and 1901.183 and to enact sections 956.01 to 956.19, 956.98, and 956.99 of the Revised Code to establish licensing requirements and standards of care for certain dog breeding kennels and dog intermediaries.

Mr. President:

I am directed to inform you that the House of Representatives has concurred in the passage of the following bill:

**Sub. S. B. No. 16** -By Initiative.

Cosponsors: Senator Amstutz Representatives Batchelder, Bupp, Domenick, Hagan, J., Hottinger, Huffman, Wagner.

To amend section 503.52 and to enact sections 715.55 and 2907.40 of the Revised Code to restrict the hours of operation of sexually oriented businesses, to prohibit patrons and employees of a sexually oriented business who are not immediate family members from touching each other while on the premises of that business and while the employee is nude or seminude, and to require the state to indemnify a township or municipal corporation for liability incurred in enforcing a resolution or ordinance that regulates adult entertainment establishments, is adopted in conformance with the Attorney General's guidance, and is found by a court to be unconstitutional or otherwise legally defective.

As a substitute bill, in which the concurrence of the Senate is requested.

To amend section 5747.37 of the Revised Code to increase the income tax adoption credit from \$500 per child to \$1,500.

With the following additional amendments, in which the concurrence of the Senate is requested.

In line 23, delete everything after the period and insert " The taxpayer shall claim the credit for each child beginning with the taxable year in which the child was legally adopted. If the sum of the credit to which the taxpayer would otherwise be entitled under this section is greater than the tax due under section 5747.02 of the Revised Code for that taxable year after allowing for any other credits that precede the credit under this section in the order required under section 5747.98 of the Revised Code, such excess shall be allowed as a credit in each of the ensuing two taxable years, but the amount of any excess credit allowed in any such taxable year shall be deducted from the balance carried forward to the ensuing taxable year."

Delete lines 24 through 27

In line 28, delete everything before "The"
