To amend section 4141.312 of the Revised Code to specify conditions under which a claimant's unemployment compensation benefits are not reduced by the amount the claimant concurrently receives in social security retirement benefits and to declare an emergency.

With the following additional amendments, in which the concurrence of the Senate is requested.

After line 41, insert:

"Section 3. This act is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety. The reason for such necessity is to provide immediate assistance to individuals who are deprived currently of their full unemployment compensation benefits

under Ohio law. Therefore, this act shall go into immediate effect."

In line 5 of the title, after "benefits" insert "and to declare an emergency"

Sub. S.B. 311 of the 126th General Assembly to specify administration dates for the elementary achievement tests, to allow public schools to charge tuition for all-day kindergarten, to require the Department of Education to conduct a survey of the fees charged by school districts, to revise the requirements regarding criminal records checks of school employees, to require the Educator Standards Board to recommend a code of conduct for educators, to require the Department of Education to recommend penalties for failure to report educator misconduct, to permit the State Board of Education to revoke an expired license, to permit waivers from the minimum number of school days in the 2006-2007 school year for certain joint vocational school districts that experienced delays in a state-assisted construction project, to extend the deadline for the commission studying student success with the Ohio Core curriculum to issue its recommendations, to alter the membership of the Ohio Community Service Council, and to declare an emergency, was considered the third time.
