INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 416-Representative Snitchler.

Cosponsors: Representatives Blessing, Lehner, Murray, Blair, Derickson, Boose, Wagner, Phillips, Stebelton, Amstutz, Sears, McGregor.

To amend sections 3109.14, 3705.23, 3705.24, 3705.242, 4507.23, 4507.24, 4507.50, and 4507.52 and to enact section 3705.243 of the Revised Code to waive the fees charged for birth records, state identification cards, temporary instruction permits, driver's licenses, motorcycle operator's endorsements, and motorized bicycle licenses issued to individuals who are under age twenty-two and, because of age, no longer qualify for foster care maintenance payments.

H. B. No. 417-Representative Driehaus.

Cosponsors: Representatives Murray, Fende, Stautberg, Foley, Ujvagi, Hagan.

To amend sections 4301.04, 4303.26, 4303.292, and 4303.99 and to enact section 4303.294 of the Revised Code to revise the appeal procedures for the refusal to issue, renew, or transfer a retail liquor permit and to require permit holders that violate the laws governing liquor control to file the names and addresses of their employees with the Division of Liquor Control.

H. B. No. 418-Representative Boose.

Cosponsors: Representatives Grossman, Dyer, Martin, Letson, Weddington, Combs.

To enact section 5.083 of the Revised Code to adopt the Buckeye candy as the official confection of the state.

Said bills were considered the first time.
