### INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 427-Representatives Schneider, Sykes.

Cosponsors: Representatives Brown, DeGeeter, Dodd, Domenick, Phillips, Yuko.

To enact section 2315.50 of the Revised Code to declare how monetary awards in class actions that are not paid over to members of the class are to be used.

### H. B. No. 428-Representatives Boose, Amstutz.

Cosponsors: Representatives Burke, Bubp, Jordan, Combs, Ruhl, Mecklenborg, Grossman, Stautberg, Gardner, McClain, Blair, Stebelton, Pryor, Harwood, Adams, J., Martin, Huffman, Maag, Evans, Adams, R., Derickson, Zehringer, Wachtmann, Uecker, Blessing, Oelslager, Hall, Beck, Balderson, Snitchler, Batchelder, Daniels, Morgan, Hottinger, Goodwin, Baker.

To amend sections 4501.06, 4503.04, 4503.042, 4503.07, 4506.08, and 4507.23 of the Revised Code to eliminate the late fee of twenty dollars for motor vehicle registrations, commercial driver's licenses, driver's licenses, and motorcycle endorsements established by the biennial transportation appropriations act of the 128th General Assembly for deposit primarily into the State Highway Safety Fund.

## H. B. No. 429-Representatives Harris, Lehner.

Cosponsors: Representatives Hagan, Domenick, Lundy, Stewart, Dyer, Brown, Foley, Luckie, Yuko, Garland, Pillich.

To amend sections 121.22, 149.43, 2919.25, 2919.27, 2923.13, 2935.03, 2935.032, and 4731.22 and to enact sections 109.44, 307.6210, 307.6211, 307.6212, 307.6213, 307.6214, 307.6215, 307.6216, 307.6217, 307.6218, and 3701.048 of the Revised Code to increase the penalties for domestic violence, to authorize a court to issue a protection order against a person convicted of

domestic violence and to prohibit violation of such a protection order, to require a peace officer who has reasonable grounds to believe that a violation of a protection order has been committed to arrest any person who the peace officer has reasonable cause to believe is guilty of the violation, to require an offender who commits domestic violence to meet periodically with the sentencing judge and attend a batterer intervention program, to authorize a board of county commissioners to create a domestic violence fatality review board, and to require the Attorney General to track the issuance and violation of protection orders.

**H. B. No. 430**-Representatives Goodwin, Morgan. Cosponsors: Representatives Baker, Blair, Blessing, Boose, Combs, Grossman, Huffman, Adams, J., Stebelton.

To enact section 124.16 of the Revised Code to base the total amount that the administrative departments spend on the salaries or wages of their employees on changes in the Gross Domestic Product of Ohio.

Mr. Speaker:

I am directed to inform the House of Representatives that the Senate has passed the following bills in which the concurrence of the House is requested:

### Sub. S. B. No. 4 - Senator Schaffer

Cosponsors: Senators Buehrer, Carey, Gibbs, Gillmor, Grendell, Harris, Jones, Niehaus, Patton, Schuring, Widener, Seitz, Hughes, Faber, Stewart, Wilson

To enact section 117.114 of the Revised Code to require the Auditor of State to conduct performance audits of the Bureau of Workers' Compensation, Environmental Protection Agency, Department of Natural Resources, Department of Agriculture, and Department of Health, and to require the Auditor of State to develop a schedule to provide for periodic performance audits of all state agencies.

### Sub. S. B. No. 155 - Senators Carey, Miller, D.

Cosponsors: Senators Buehrer, Cafaro, Fedor, Gibbs, Goodman, Harris, Hughes, Kearney, Morano, Niehaus, Schaffer, Schiavoni, Strahorn, Widener, Gillmor, Turner, Sawyer, Smith, Miller, R.

To amend sections 117.13, 1515.14, and 3734.901 of the Revised Code and to amend Section 343.40 of Am. Sub. H.B. 1 of the 128th General Assembly to require that the costs of all biennial audits of state agencies be charged to the state agency being audited, to alter the allocation of the proceeds of the existing fee on the sale of new tires in order to provide funding for the Soil and Water Conservation District Assistance Fund, and to increase the maximum amount of the annual soil and water conservation district subsidy.

### S. B. No. 185 - Senator Jones

Cosponsors: Senators Buehrer, Grendell, Husted, Schaffer, Wagoner, Carey, Faber, Gibbs, Hughes, Niehaus, Widener, Goodman

To amend section 127.14 and to enact section 126.231 of the Revised Code, and to amend Section 512.60 of Am. Sub. H.B. 1 of the 128th General Assembly to prohibit the transfer of cash from certain non-General Revenue Funds to the General Revenue Fund.

### Sub. S. B. No. 213 - Senator Faber

Cosponsors: Senators Schaffer, Jones, Grendell, Hughes, Cates, Buehrer, Carey, Gibbs, Gillmor, Goodman, Harris, Niehaus, Patton

To amend sections 4123.29 and 4123.321 of the Revised Code to require the Administrator of Workers' Compensation to make specified changes concerning workers' compensation premium rates and to prohibit the Bureau of Workers' Compensation Board of Directors from issuing a refund or rebate to subscribers to the State Insurance Fund without approval of the General Assembly.
