INTRODUCTION OF BILLS

To enact sections 2746.01, 2746.02, 2746.03, 2746.04, 2746.05, 2746.06, 2746.07, and 2746.08 of the Revised Code to provide consolidated references to Revised Code sections that establish costs and fees, other than attorney fees, in the courts of record of this state.

H. B. No. 432-Representative Pryor.

To amend section 4141.01 and to enact sections 4141.50 to 4141.55 of the Revised Code to create the shared work unemployment compensation program.

H. B. No. 433-Representatives Ujvagi, Grossman.

Cosponsors: Representatives Fende, Yuko, Letson, Skindell, Brown, Derickson, Lundy, Lehner, Hagan, Pillich, Stewart, Bolon.

To amend section 5923.05 of the Revised Code to provide publicly employed fire fighters and emergency medical technicians with a minimum paid military leave of seventeen 24-hour days.

new Sections 4, 5, and 8 of Article XI, and to repeal Sections 3, 4, 5, 7, 8, 9, 10, 11, and 14 of Article XI of the Constitution of the State of Ohio to revise the process for apportioning the state for General Assembly districts.
