### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 439**-Representatives Phillips, Stewart.

Cosponsors: Representatives Garland, Okey, Domenick, Yuko.

To amend sections 1551.20, 5709.53, and 5747.01 of the Revised Code to exempt from property taxation the cost of energy-conservation or renewable energy improvements to business property and to authorize an additional income tax deduction for the costs of such improvements if the property is sold for a gain.

**H. B. No. 440**-Representative Balderson.

Cosponsors: Representatives Batchelder, Jordan, Blessing, Domenick, Evans, Morgan, Boose, McClain, Adams, J., Wagner, Zehringer, Amstutz, Stebelton, Bacon.

To enact section 5111.0122 of the Revised Code to require the Director of Job and Family Services to seek federal approval to establish an alcohol and controlled substance testing and treatment component of the Medicaid program.

**H. B. No. 441**-Representative Grossman.

To enact section 5533.686 of the Revised Code to designate part of Interstate 71 in southern Franklin County as the "Deputy Marty Martin Memorial Highway."

**H. B. No. 442**-Representative Yuko.

Cosponsors: Representatives Slesnick, Wachtmann, Hagan, Letson, Goodwin, Adams, J., Ujvagi.

To amend section 4759.02 and to enact sections 4783.01 to 4783.05 of the Revised Code regarding the provision of complementary or alternative health services.

**H. B. No. 443**-Representative Gerberry.

Cosponsors: Representatives Hagan, Harwood, Phillips, Fende, Ujvagi, Murray, Mallory, Williams, B., Bolon, Letson, Domenick, Lundy, Harris, Newcomb, Moran, Yuko, Winburn, Dyer, Weddington.

To enact sections 4930.01, 4930.02, 4930.03, 4930.04, 4930.05, 4930.06, 4930.07, 4930.08, 4930.09, 4930.10, 4930.11, 4930.12, 4930.13, and 4930.14 of the Revised Code to create the Energy Efficiency Stakeholder Advisory Group to review energy efficiency and peak demand reduction programs and related matters and to require the group to make a recommendation regarding its continuation to the General Assembly by December 31, 2024.

**H. B. No. 444**-Representative Goyal.

Cosponsors: Representatives Letson, Domenick, Grossman, Mecklenborg, Evans, Slesnick.

To amend section 4501.21 and to enact section 4503.524 of the Revised Code to create Power Squadron license plates.

**H. B. No. 445**-Representative Letson.

Cosponsors: Representatives Domenick, McGregor, Yuko, Bolon, Hagan.

To amend section 4303.29 and to enact section 4301.82 of the Revised Code to establish local entertainment districts in municipal corporations or unincorporated areas of counties of specified populations for the purpose of the issuance of D-1, D-2, and D-5 liquor permits under specified conditions.

**H. B. No. 446**-Representative Harris.

Cosponsors: Representatives Hagan, Domenick, Foley, Heard, Letson, Combs, Brown.

To amend sections 2151.353, 2151.354, and 2152.19 and to enact section 3109.90 of the Revised Code to require that any privately run non-Ohio agency, home, school, camp, institution, or other entity or residential facility to which Ohio abused, neglected, dependent, unruly, or delinquent children are committed comply with the same standards that are applicable to in-state agencies, homes, schools, camps, institutions, or other entities or residential facilities.
