INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 32-Representative Ruhl.

To amend section 755.29 of the Revised Code to increase the competitive bidding threshold for contracts entered into by a board of park trustees for certain municipal park improvements.

H. B. No. 33-Representative Dyer.

Cosponsors: Representatives Hagan, Williams, B., Boyd, Chandler, Harris, DeBose, Winburn.

To enact sections 319.64, 3745.25, and 5502.71 of the Revised Code to require law enforcement agencies to report to the Director of Public Safety the location of any real property on which and the vehicle identification number of any motor vehicle in which an illegal methamphetamine manufacturing laboratory has been discovered, to require the Director of Public Safety to maintain on the Department of Public Safety web site a database of properties on which and motor vehicles in which illegal methamphetamine manufacturing laboratories have been discovered, to authorize a county recorder to record an instrument identifying any property that has been included in that database, and to provide a means by which an owner of property or a motor vehicle included in that database may receive certification from the Director of Environmental Protection that the property or motor vehicle has been cleared of methamphetamine residue and have the property or motor vehicle removed from the database.

To amend sections 6115.04, 6115.05, 6115.06, 6115.08, 6115.16, 6115.46, and 6115.69 and to enact sections 6115.051, 6115.081, 6115.082, 6115.091, 6115.092, 6115.093, 6115.094, 6115.095, 6115.096, and 6115.321 of the Revised Code to revise the law governing sanitary districts that are organized wholly for the reduction of populations of biting arthropods.

H. B. No. 36-Representative Dyer.

To amend section 101.15 and to enact sections 101.151 and 101.16 of the Revised Code to require expanded minutes for legislative committee meetings or a transcribed record of committee proceedings in lieu of minutes, and to require sworn testimony of all witnesses testifying before legislative committees.

H. B. No. 37-Representative Dyer.

To amend section 9.312 and to enact section 125.112 of the Revised Code to require the Department of Administrative Services to maintain a web site database including apparent low bidders who failed to be awarded a contract because they were found not to be "responsible," and to require public entities to conduct investigations when apparent low bidders are suspected of failing or fail to meet the "responsible" prong of the "responsive and responsible" competitive bidding threshold.
