INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 40-Representative Letson.

To enact section 3109.054 of the Revised Code to require certain employers to allow a parent to exercise court-ordered parenting time without terminating employment, reducing pay, or taking other similar action against the parent.

To amend section 3770.06 and to enact section 3317.0212 of the Revised Code to require that a portion of lottery profits be distributed annually on a per pupil basis to public and chartered nonpublic schools.

To amend sections 4509.101 and 4510.04 of the Revised Code and to repeal Section 3 of Am. Sub. S.B. 20 of the 120th General Assembly, as subsequently amended, to eliminate the financial responsibility random verification program of the Bureau of Motor Vehicles.

To amend section 4513.03 of the Revised Code to require the headlights of a vehicle to be lighted when its windshield wipers are in use.

To amend section 4141.29 of the Revised Code to permit persons who quit work to accompany the person's spouse on a military transfer to be eligible for unemployment compensation benefits.

employee who is the spouse or parent of a member of the uniformed services who is called to active duty or is injured, wounded, or hospitalized while serving in a combat zone.
