" (B) Each retail dealer is allowed a vendor discount equal to nine-tenths of one per cent of the motor fuel taxes paid on motor fuel purchased by the retail dealer each semiannual period beginning July 1, 2009, and thereafter. The vendor discount shall be refunded to the retail dealer upon application by the dealer to the tax commissioner within one hundred twenty days after the end of each such semiannual period in the manner prescribed by the tax commissioner. The vendor discount is in addition to any other refund allowed the dealer under division (A) of this section.
