Mr. Speaker:

I am directed to inform the House of Representatives that the Senate has passed the following bills in which the concurrence of the House is requested:

Am. S. B. No. 35 -Senator Stewart

Cosponsors: Senators Seitz, Cates, Faber, Gibbs, Harris, Niehaus, Patton, Schaffer, Schuring

To enact section 109.45 of the Revised Code to direct the Attorney General to pursue a memorandum of agreement that permits the enforcement of federal immigration laws in this state by law enforcement officers.

S. B. No. 150 -Senator Cates

Cosponsors: Senators Buehrer, Gibbs, Seitz, Schaffer, Patton, Schuring, Husted, Faber, Hughes, Harris, Niehaus

To amend sections 9.63, 311.07, and 341.21 of the Revised Code to provide

that a board of county commissioners may direct a sheriff to take custody of persons who are being detained for deportation or who are charged with civil violations of immigration law and to expressly authorize state and local employees and county sheriffs to render assistance to federal immigration officials in the investigation and enforcement of federal immigration law.

S. B. No. 192 - Senators Cates, Seitz

Cosponsors: Senators Niehaus, Buehrer, Wagoner, Gibbs, Gillmor, Goodman, Harris

To amend section 3319.081 and to enact section 3319.0810 of the Revised Code to permit non-Civil Service school district boards to terminate positions of district transportation employees for reasons of economy and efficiency and to contract with independent agents to provide transportation services as long as certain conditions are satisfied.
