INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 104-Representative Stebelton.

To enact sections 303.214, 519.214, and 713.082 of the Revised Code to codify federal restrictions on local zoning of the antenna structures of amateur radio stations and place the burden of proof for compliance on the zoning authority.

To enact section 5.2265 of the Revised Code to designate March as "Macular Degeneration Awareness Month."

To amend section 123.01, to enact sections 131.50, 1509.50, 1509.51, 1509.52, 1509.53, and 1509.54, and to repeal sections 5119.40, 5120.12, and 5123.23 of the Revised Code to create the Oil and Gas Leasing Board and to establish a procedure by which the Board may enter into leases for oil and gas production on land owned or under the control of a state agency for the purpose of providing funding for capital and operating costs for the agency.

H. B. No. 108-Representatives Domenick, Blessing.

To amend section 959.99 of the Revised Code to increase the penalty for cockfighting.

H. B. No. 109-Representatives Hottinger, Weddington.

To amend section 4506.16 of the Revised Code to require the Registrar of Motor Vehicles to disqualify the holder of a commercial driver's license from operating a commercial motor vehicle upon a municipal OVI conviction.

H. B. No. 110-Representative Adams, J.
