INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 111-Representative DeGeeter.

To amend section 721.15 of the Revised Code to reduce, from fifteen to ten, the minimum number of days for bidding when a nonchartered municipal corporation sells personal property by Internet auction.

To amend sections 2903.213 and 2919.26 of the Revised Code to authorize a court that issues a temporary protection order in specified criminal cases to require the alleged offender, as a condition of pretrial release, to be monitored by a global positioning system device at the alleged offender's expense.

To amend sections 133.06, 133.20, 3313.372, 3313.46, and 4928.62 and to enact section 3313.377 of the Revised Code to authorize school boards, for on-site renewable energy generation measures and in the same manner as for energy conservation measures, to enter into installment contracts subject to specified terms of payment, to provide that energy conservation installment contracts are subject to those same terms, and to require that at least twenty-five per cent of the schools in the state's school districts have a long-term supply of solar-sourced electricity.
