### INTRODUCTION OF BILLS

The following bills were introduced:

### **H. B. No. 475**-Representative Mallory.

Cosponsors: Representatives Book, Brown, Otterman, Hagan, Letson, Domenick, Reece, Winburn, Williams, S.

To amend section 3773.32 of the Revised Code to exempt boxing, karate, or wrestling matches that benefit a charitable organization conducted under the supervision of the fraternal order of police of Ohio or the Ohio association of professional firefighters from regulation by the Ohio Athletics Commission.

### H. B. No. 476-Representative Yuko.

Cosponsors: Representatives Domenick, Harwood, Winburn, Letson, Brown.

To enact section 3901.046 of the Revised Code to establish a statewide life insurance database.

### **H. B. No. 477**-Representative Yuko.

Cosponsors: Representatives Letson, Domenick, Fende, Okey, Brown.

To enact section 5.2266 of the Revised Code to designate September as "Pain Awareness Month."

### H. B. No. 478-Representative Yuko.

Cosponsors: Representatives Hagan, Foley, Okey, Sykes, Stewart.

To amend sections 2925.02, 2925.03, 2925.04, 2925.11, 2925.14, and 3781.32 and to enact sections 2925.43, 2925.44, 2925.45, 2925.46, 3728.01, 3728.02, 3728.03, 3728.04, 3728.05, 3728.06, 3728.07, 3728.08, 3728.10, 3728.11, 3728.12, 3728.13, 3728.14, 3728.15, 3728.16, 3728.17, 3728.18, 3728.20, 3728.21, 3728.22, 3728.25, 3728.26, 3728.27, 3728.28, 3728.29, 3728.30, 3728.31, 3728.35, 3728.351, 3728.37, 3728.38, 3728.381, 3728.40, 3728.41, 3728.42, 3728.43, 3728.45, 3728.47, and 3728.99 of the Revised Code regarding the medical use of cannabis.

### H. B. No. 479-Representative Weddington.

Cosponsors: Representatives Heard, Lehner, Luckie.

To enact section 3314.019 of the Revised Code to permit the establishment of a community school to serve adults of school age who are incarcerated or who have been released from the custody of the Department of Youth Services and to declare an emergency.

# H. B. No. 480-Representatives Slesnick, Oelslager.

To amend section 2903.13 of the Revised Code to increase the penalty for assault to a felony of the fourth degree when the victim is a hospital employee or health care worker who is engaged in the performance of the individual's duties at a hospital.

Said bills were considered the first time.
