INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 123-Representatives Goyal, Mandel.

Cosponsors: Representatives Adams, J., Amstutz, Bacon, Baker, Blair, Blessing, Boose, Boyd, Brown, Bulp, Burke, Combs, Derickson, Domenick, Dyer, Evans, Fende, Grossman, Hall, Harris, Hite, Huffman, Jordan, Luckie, Maag, McClain, Mecklenborg, Morgan, Newcomb, Okey, Pillich, Pryor, Schneider, Snitchler, Stautberg, Stebelton, Ujvagi, Williams, S., Winburn, Yuko, Zehringer.

To amend sections 5747.08 and 5747.98 and to enact sections 718.17, 3333.51, and 5747.81 of the Revised Code to grant an income tax credit to individuals who earn degrees in science, technology, engineering, or math-based fields of study and to authorize municipal corporations to grant a credit to individuals qualifying for the state credit.

H. B. No. 124-Representatives Hagan, Weddington.

To amend sections 955.02, 955.10, 955.12, 955.20, 955.26, and 1901.183 and to enact sections 956.01, 956.011, 956.02 to 956.08, 956.081, 956.09 to 956.20, 956.98, and 956.99 of the Revised Code to establish licensing requirements and standards of care for certain dog breeding kennels, dog intermediaries, and animal rescues for dogs.

H. B. No. 125-Representative Williams, S.

Cosponsors: Representatives Luckie, Hagan, Mallory, Harris, Pryor, Foley.

To amend sections 5111.019 and 5111.16 and to enact sections 5111.83, 5111.831, 5111.832, 5112.22, 5112.23, 5112.24, 5112.25, 5112.26, and 5112.27 of the Revised Code to require the Director of Job and Family Services to seek federal permission to establish the Family Health Plus

component of the Medicaid program, to impose a new assessment on hospitals, and to earmark the proceeds from the new assessment for the Family Health Plus component.

H. B. No. 126-Representative Williams, S.

To amend sections 169.13 and 169.14 of the Revised Code to require the director of budget and management to withhold from an unclaimed funds payment any legal amount in an agreement to compensate a registered finder and to pay that amount directly to the finder.

To amend sections 4510.02, 4510.036, 4511.21, 4511.33, 4511.41, 4511.42, 4511.43, 4511.431, 4511.44, 4511.441, 4511.45, 4511.451, 4511.46, 4511.47, and 4513.39 and to enact section 4501.14 of the Revised Code to provide for increased penalties when a person violates the motor vehicle traffic law assured clear distance ahead provision or commits a failure to yield the right-of-way offense that results in serious physical harm or death to another person.

H. B. No. 129-Representative Adams, J.

Cosponsors: Representatives Balderson, Blair, Boose, Bulp, Burke, Combs, Goodwin, Hall, Hite, Huffman, Jordan, Maag, Martin, Mecklenborg, Morgan, Sears, Snitchler, Uecker, Wachtmann.

To amend sections 1547.69, 2923.11, 2923.12, 2923.122, 2923.123, 2923.124, 2923.125, 2923.126, 2923.128, 2923.1212, 2923.1213, and 2923.16

of the Revised Code to authorize a person to carry a concealed handgun without obtaining a license to the same extent as if the person had obtained such a license, except on liquor permit premises, if the person qualifies for a concealed carry license and is legally permitted to purchase a handgun; to remove the requirements that a concealed carry licensee must be carrying the license in order to carry a concealed handgun, must inform approaching law enforcement officers that the person has a license and is carrying the handgun when the person is carrying a concealed handgun, and must submit a new or renewed competency certification when renewing the license; to eliminate as premises in which a concealed carry licensee may not carry a concealed handgun public or private institutions of higher education, places of worship, day-care centers and homes, and government buildings other than schools, courthouses, law enforcement offices, and correctional facilities; to replace the prohibitions that apply only to a concealed carry licensee who is carrying a handgun in a motor vehicle with a prohibition against a licensee who is in a motor vehicle that is stopped by a law enforcement officer knowingly menacing or threatening an officer with a loaded handgun or knowingly pointing a loaded handgun at an officer; to remove the "in plain sight or secure encasement" criterion that a concealed carry licensee must satisfy to legally possess a handgun in a motor vehicle; and to require a sheriff who issues a renewed concealed carry license to return the expired license to the licensee or destroy it.

H. B. No. 130-Representative Miller.

Cosponsors: Representatives Ujvagi, Pillich, Letson, Domenick.

To amend sections 4507.05 and 4507.071 of the Revised Code to prohibit a person who is less than 17 years of age from talking or text messaging on a mobile communication device while driving.

Said bills were considered the first time.
