INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 481-Representatives Harwood, Bubp.

Cosponsors: Representatives Harris, Grossman, Sears, Szollosi, Pillich, Gardner, Murray, Gerberry, Garland, Boyd, Uecker, Phillips, Lundy, Williams, B., Williams, S., Hagan, Evans, Winburn, Huffman, Skindell, Letson, Domenick, Pryor, Brown, McGregor, Adams, R.

To enact section 5.2266 of the Revised Code to designate March as Women's Veterans Month.

H. B. No. 482-Representative Garland.

Cosponsors: Representatives Bacon, Carney, Celeste, Grossman, Harris, Heard, Stewart, Weddington.

To amend section 755.14 and to enact section 755.141 of the Revised Code to authorize a joint recreation district operating on the site of the United States Christopher Columbus Quincentenary Jubilee to issue revenue bonds, maintain lines of credit, and enter into lease purchase agreements for property; to expand the district's powers with respect to its own property; and to make certain appointments to the district's board permissive rather than mandatory.

H. B. No. 483-Representative Pryor.

To amend sections 135.631, 135.74, and 135.75 of the Revised Code to modify the Agricultural Linked Deposit Program with respect to the maximum amount the Treasurer of State may invest in agricultural linked deposits and the interest rate at which loans are made under the Program.

H. B. No. 484-Representative Pryor.

To enact section 5533.221 of the Revised Code to designate a portion of State Route 104 within Ross County as the "David A. Gibson Memorial Highway."

H. B. No. 485-Representative Pryor.

Cosponsor: Representative Domenick.

To amend sections 303.01, 519.01, and 5713.30 of the Revised Code to include the production from certain feedstocks of biodiesel, biomass energy, electric or heat energy, and biologically derived methane gas in the definition of "agriculture" for purposes of the laws governing county zoning, township zoning, and current agricultural use valuation.

H. B. No. 486-Representatives Lundy, Stebelton.

Cosponsors: Representatives Foley, Celeste, Skindell, Dyer, Stewart, Sykes, Harris, Murray, Driehaus, Heard, Belcher, Hagan, Garland, Letson, Yuko.

To amend sections 1315.26, 1321.13, 1321.15, 1321.57, 1321.59, and 1321.99 of the Revised Code to establish certain consumer protections with respect to small loans to be known as the Small Loan Consumer Protection Act.
