INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 140-Representatives Goyal, Schneider.

To amend section 3345.12 and to enact section 3345.36 of the Revised Code to permit institutions of higher education to facilitate and assist with entrepreneurial projects for economic development and to authorize the institutions to enter into agreements to induce development of, acquire ownership in, and make or guarantee loans and incur debt to fund the entrepreneurial projects.

H. B. No. 141-Representative Dodd.

To amend sections 711.05, 711.10, 3718.01, 3718.02, 3718.03, 3718.04, 3718.05, 3718.06, 3718.09, and 6117.51 and to enact sections 3718.011, 3718.023, 3718.024, 3718.025, and 3718.041 of the Revised Code, to amend sections 711.05 and 711.10 of the Revised Code, which are scheduled to take effect on July 1, 2009, to amend Section 120.05 of Am. Sub. H.B. 119 of the 127th General Assembly, and to repeal Sections 120.01 and 120.02 of Am. Sub. H.B. 119 of the 127th General Assembly to revise the Household Sewage and Small Flow On-Site Sewage Treatment Systems Law, and to declare an emergency.

H. B. No. 142-Representative Gardner.

To amend section 5321.01 and to enact section 5321.20 of the Revised Code to enable members of the armed services and the Ohio National Guard to terminate a rental agreement when the member receives military orders to deploy or for a permanent change of station, was taken up for consideration the third time. To amend sections 1547.11, 2919.25, 2929.13, 4506.17, 4511.19, 4765.38, and 4765.39 and to enact section 2927.15 of the Revised Code to prohibit a person from collecting any bodily substance of another person without privilege or consent to do so, to correct erroneous cross-references in provisions enacted in Am. Sub. H.B. 280 of the 127th General Assembly regarding increased penalties for domestic violence committed against a pregnant woman, and to permit emergency medical technicians-intermediate and emergency medical technicians-paramedic to withdraw blood for the purposes of the watercraft or vehicle OVI law or the commercial motor vehicle law.
