The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 151**-Representatives Pryor, Pillich.

Cosponsors: Representatives Boyd, Dodd, Fende, Hagan, Harwood, Okey, Phillips, Weddington, Williams, B., Yuko.

To enact section 4511.109 of the Revised Code to require the Department of Transportation to install directional and informational signs on state highways to indicate the location of United States Department of Veterans Affairs medical centers, outpatient clinics, and community-based outpatient clinics.

**H. B. No. 152**-Representative Pryor.

Cosponsors: Representatives Brown, Dodd, Garland, Harris, Harwood, Letson, Phillips, Pillich, Williams, B., Yuko.

To enact sections 4503.548 and 4503.549 of the Revised Code to create the Vietnam Combat Infantry and Combat Medic license plates.

**H. B. No. 153**-Representative Yuko.

Cosponsors: Representatives Williams, B., Luckie, Hagan, Domenick, Evans, Letson.

To amend sections 109.71, 109.73, and 109.77 and to enact sections 6119.60, 6119.61, 6119.62, 6119.63, and 6119.64 of the Revised Code to authorize regional water and sewer districts to establish police departments.

**H. B. No. 154**-Representative Yuko.

Cosponsors: Representatives Williams, B., Patten, Luckie, Hagan, Domenick, Stewart, Evans, Winburn.

To amend sections 2921.331, 4510.036, and 4510.31 of the Revised Code to prohibit a person who is not operating a motor vehicle from fleeing from a law enforcement officer who gives a lawful order to stop and to increase the minimum penalty for fleeing and eluding a police officer in a motor vehicle

after receiving a visible or audible signal to stop.

**H. B. No. 155**-Representative Yuko.

Cosponsors: Representatives Hagan, Domenick, Ujvagi, Boyd.

To amend sections 2915.01 and 2915.091 of the Revised Code to change the definition of "instant bingo ticket dispenser" and to authorize a charitable organization to purchase, lease, and use instant bingo ticket dispensers.

Said bills were considered the first time.
