The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative DeGeeter was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 167-Representative Murray.

Cosponsors: Representatives Foley, Heard, Slesnick, Domenick, Hagan, Letson, Luckie, Yuko, Weddington, Harris, Boyd, Phillips, Okey, Williams, S., Pillich.

To enact sections 4113.80 to 4113.84 and 5321.171, 5321.172, and 5321.173 of the Revised Code to prohibit an employer or a landlord from discriminating against a victim of domestic violence, to allow a victim of domestic violence to take unpaid leave for court proceedings relating to the incident of domestic violence, to allow a tenant who is a victim of domestic violence to change or have changed the locks to the tenant's dwelling unit, and to allow such a tenant to terminate a lease.

H. B. No. 168-Representatives Murray, Ujvagi.

Cosponsors: Representatives Yuko, Hagan, Williams, S., Chandler, Luckie, Okey, Letson, Foley, Gardner, Hite.

To enact sections 149.32 and 149.321 of the Revised Code to establish the War of 1812 Bicentennial Commission, to prescribe the Commission's powers and duties, and to repeal sections 149.32 and 149.321 of the Revised Code on December 31, 2015, to terminate the commission on that date.

H. B. No. 169-Representative Murray.

Cosponsors: Representatives Foley, Hagan, Domenick, Boyd, Okey.

To amend section 4563.10 of the Revised Code to apply the Airport Zoning Law to public utility or railroad buildings or structures that create an airport hazard.

H. B. No. 170-Representative Murray.

Cosponsors: Representatives Okey, Foley, Domenick, Yuko, Skindell, Boyd, Pillich.

To enact section 4141.49 of the Revised Code to prohibit an employer from retaliating against the employer's employees for testifying or otherwise participating in an unemployment compensation proceeding or hearing.

H. B. No. 171-Representatives Letson, Mandel.

Cosponsors: Representatives Weddington, Boyd, Luckie, Heard, Chandler, Batchelder.

To amend section 4505.01 and to enact section 4505.063 of the Revised Code to apply the motor vehicle certificate of title law to trailers and semitrailers that weigh 4,000 pounds or less and are not farm trailers.

H. B. No. 172-Representative Letson.

Cosponsors: Representatives Phillips, Yuko, Hagan, Domenick, Harwood, Brown.

To amend sections 331.01, 331.02, 331.03, and 331.04 of the Revised Code to expand the authority of a county facilities review board to include any facility where a ward of the probate court resides or where such ward receives services among the institutions subject to its review.

Said bills were considered the first time.
