To amend section 3311.06 of the Revised Code to prohibit an urban school district that is a party to an annexation agreement from declining to extend the agreement.

In memory of The Honorable Thomas J. Moyer

WHEREAS, The members of the House of Representatives of the 128th General Assembly of Ohio extend our sincere condolences to the family and friends of The Honorable Thomas J. Moyer on the sorrowful occasion of his death; and

WHEREAS, Thomas Moyer's zealous love of life and his selfless concern for the welfare of others distinguished him as an outstanding human being and as a leading citizen. Elected chief justice of the Ohio Supreme Court in 1986, he held the posts of judge of the Court of Appeals of Franklin County, executive Assistant to the Governor of Ohio, and an attorney in private practice, and he spearheaded the restoration of the Ohio Judicial Center. He was a dedicated and devoted public servant whose exemplary career serves as an inspiration for others; and

WHEREAS, A man of exceptional concern and insight, Thomas Moyer also achieved a praiseworthy record of service to the community as president of the Conference of Chief Justices and the Columbus Bar Association, as chair of the National Committee on Emergency Preparedness in the Courts for the Conference of Chief Justices and the board of The Ohio State University Alumni Association, and as a member of the Board of Trustees of Franklin University, the National Board of The Einstein Institute for Science, Health and the Courts, and the Board of the Advanced Science and Technology Adjudication Resource Project. He will long be remembered for his kindness and his unwavering commitment to service; and

WHEREAS, Thomas Moyer's personal sacrifices of time and energy to his family, his friends, his community, and the State of Ohio will certainly live beyond him. The world is a richer place for his having been in it, and the vitality and commitment of this exceptional human being and exemplary citizen will be remembered fondly by all those who knew and loved him, including his wife, Mary, his son, Drew, his four stepchildren, Anne, Alaine, Elizabeth, and John, and his four grandchildren, Faith, Carson, Leigh, and Ariel; therefore be it
