The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Okey was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 523**-Representatives Phillips, Driehaus.

Cosponsors: Representatives Patten, Murray, Weddington, Letson, Hagan, Szollosi, Brown, Okey, Domenick, Dodd, Walter, Pillich, Garland, Skindell, Foley.

To amend sections 121.083, 1349.61, 4111.02, 4111.14, 4113.15, 4115.03, 4121.01, 4123.01, 4123.026, 4141.01, and 5747.01 and to enact sections 4175.01 to 4175.18 and 4175.99 of the Revised Code to create a generally uniform definition of employee for specified labor laws and to create a uniform standard to determine whether an individual performing services for an employer is an employee of that employer.

**H. B. No. 524**-Representative Phillips.

Cosponsors: Representatives Driehaus, Walter, Okey, Yuko.

To amend sections 4501.01, 4507.11, and 4511.01 and to enact sections 4511.072 and 4511.214 of the Revised Code to establish conditions for the operation of mini-trucks on certain roads.

**H. B. No. 525**-Representative Hollington.

Cosponsors: Representatives Boose, Blair, Grossman, Adams, J., Lehner, Blessing, Coley, Hottinger.

To enact section 124.824 of the Revised Code to require the Department of Administrative Services to make a high deductible health care plan available to state employees and state elected officials.

**H. B. No. 526**-Representatives Pryor, Stewart.

Cosponsors: Representatives Beck, Domenick.

To amend sections 2929.18, 2929.20, 2929.22, 2929.28, 2930.01, 2930.02, 2930.06, 2930.08, 2930.14, 2930.17, and 2930.19 and to enact section

2929.281 of the Revised Code to make restitution mandatory in cases of felonies and misdemeanor offenses of violence, to modify the determination and enforcement of restitution, and to enhance the participation of crime victims and crime victim advocates in the sentencing or disposition and judicial or early release of offenders and delinquent children.

**H. B. No. 527**-Representative Pryor.

Cosponsors: Representatives Garrison, Hagan, Yuko.

To enact section 3937.381 of the Revised Code to prohibit auto insurers from requiring, recommending, or suggesting that a claimant on a policy have the claimant's vehicle repaired at a particular repair shop or by a particular person unless the claimant requests a recommendation or suggestion.

**H. B. No. 528**-Representatives Pryor, Phillips.

Cosponsors: Representatives Amstutz, Balderson, Book, Boose, Brown, Derickson, Evans, Fende, Garland, Hottinger, Murray, Newcomb, Patten, Ruhl, Williams, B., Zehringer.

To amend sections 4503.04, 4510.037, and 4510.038 of the Revised Code to exempt farm trucks and farm buses from the vehicle registration late fee, to establish a mandatory waiver of the registration late fee for vehicles used on a seasonal basis, and to allow the Director of Public Safety to approve a course in remedial driving instruction that is conducted entirely by video teleconferencing or the internet under specified circumstances.

**H. B. No. 529**-Representative DeGeeter.

To amend sections 1345.07, 1345.09, and 1345.10 and to enact section 1345.022 of the Revised Code to require a supplier in certain consumer transactions to obtain express written authorization from a consumer before charging the consumer's account.

**H. B. No. 530**-Representatives Driehaus, Mecklenborg.

Cosponsors: Representatives Blessing, Domenick, Hagan, Harris, Morgan, Pillich, Stautberg, Sykes, Uecker.

To amend sections 109.57, 3313.61, 3317.03, 3319.31, 3319.311, and 4117.01 and to enact sections 3328.01 to 3328.04, 3328.11 to 3328.15, 3328.17 to 3328.19, 3328.191, 3328.192, 3328.193, 3328.20 to 3328.26, 3328.31 to 3328.36, 3328.41, 3328.45, 3328.50, and 3328.99 of the Revised Code to permit the establishment of public college-preparatory boarding schools for at-risk students to be operated by private nonprofit entities.

Said bills were considered the first time.
