The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Driehaus was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 190-Representative Fende.

Cosponsors: Representatives McGregor, Williams, S., Moran, Huffman, Yuko, Phillips, Oelslager, Garland, Jordan, Murray, Gerberry, Brown, Bolon, Slesnick, Okey, Pillich, Letson, Hagan, Luckie, Mecklenborg, Blessing, Harwood.

To amend sections 4715.14, 4715.141, 4715.22, 4715.24, and 4715.25 and to enact sections 4715.241, 4715.242, 4715.36, 4715.361, 4715.362, 4715.363, 4715.364, 4715.365, 4715.366, 4715.367, 4715.368, 4715.369, 4715.37, 4715.371, 4715.372, 4715.373, 4715.374, and 4715.375 of the Revised Code to modify certain licensing procedures for dentists and dental hygienists and to establish the Public Oral Health Supervision Program for the provision of dental hygiene services.

H. B. No. 191-Representative Celeste.

Cosponsors: Representatives Murray, Hagan, Fende, Harris, Boyd, Okey, Chandler, Domenick, Heard, Brown.

To amend sections 2743.51, 2903.06, 2929.01, 2935.03, 4503.234, 4510.17, 4510.41, 4511.181, and 4511.251 and to enact section 4511.253 of the Revised Code to increase the penalties for street racing and to create the offense of "street racing manslaughter."

H. B. No. 192-Representative Letson.

Cosponsors: Representatives Weddington, Ujvagi, Dodd, Hagan, Luckie, Harwood, Brown.

To enact section 313.061 of the Revised Code to require the court in a civil action to tax as a cost the amount necessary to reimburse the county treasury when the coroner or the coroner's physician-employees or forensic investigators are called to testify about professional services and to provide for

the direct payment to physicians in private practice who perform autopsies for a coroner's office and are similarly called to testify.

H. B. No. 193-Representative Weddington.

Cosponsors: Representatives Heard, Stewart, Luckie, Domenick, Letson, Yuko, Okey, Ujvagi.

To enact section 5.2265 of the Revised Code to designate the second Thursday in July as "Ohio Summer Learning Day."

H. B. No. 194-Representative Dolan.

To amend Sections 120.01, 120.02, and 120.05 of Am. Sub. H.B. 119 of the 127th General Assembly that temporarily suspended the operation of certain provisions of the Household and Small Flow On-Site Sewage Treatment Systems Law and that enacted temporary provisions regarding that Law by extending the termination of the suspension and temporary law from July 1, 2009, to December 31, 2009, and to declare an emergency.

TO ABOLISH THE CRIMINAL PENALTY FOR SENDING AN UNWANTED FACSIMILE ADVERTISEMENT TO A BUSINESS ENTITY, AND TO ESTABLISH THAT A PERSON MAY RECOVER ONE THOUSAND DOLLARS IN A CIVIL ACTION FOR SUCH A VIOLATION.

H.B. No. 184 - Representative Combs, et al

TO REQUIRE EMPLOYERS TO REGISTER AND PARTICIPATE IN A STATUS VERIFICATION SYSTEM TO VERIFY THE WORK ELIGIBILITY STATUS OF ALL NEW EMPLOYEES AND TO AFFIRM THEIR PARTICIPATION ON THEIR STATE INCOME TAX RETURNS, TO SPECIFY THAT AN EMPLOYER'S FAILURE TO AFFIRM THEIR PARTICIPATION IN THE STATUS VERIFICATION SYSTEM ON THEIR STATE INCOME TAX RETURNS CONSTITUTES FALSIFICATION OR DERELICTION OF DUTY, TO REQUIRE PUBLIC AGENCIES TO CANCEL CONTRACTS WITH PRIVATE EMPLOYERS WHO DO NOT PARTICIPATE IN A STATUS VERIFICATION SYSTEM, TO REQUIRE

JAIL OFFICIALS TO MAKE A REASONABLE EFFORT TO VERIFY THE CITIZENSHIP OF CONFINED PERSONS, TO COLLECT ELECTRONIC FINGERPRINTS OF ILLEGAL ALIENS, AND TO NOTIFY THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY IN CERTAIN CIRCUMSTANCES, TO PROHIBIT POLITICAL SUBDIVISIONS FROM RESTRICTING COMMUNICATION AND COOPERATION WITH FEDERAL OFFICIALS REGARDING A PERSON'S CITIZENSHIP STATUS, TO REQUIRE JUDGES AND MAGISTRATES TO CONSIDER IMMIGRATION STATUS AND OTHER FACTORS IN DETERMINING A DEFENDANT'S BAIL, AND TO DECLARE AN EMERGENCY.
